


Prior to assembly, you will need:

#2 Phillips screwdriver



HELPFUL HINTS

- Read the directions before assembly.
- If your spreader does not spread evenly, be sure "FRONT" on the GEARBOX points to the front of the spreader. **The impeller must turn clockwise when pushing forward**. Reversing the GEARBOX during assembly will cause issues.
- Your spreader is calibrated for three miles per hour, which is a brisk walking speed. Slower or faster speeds will change the spread pattern. Wet fertilizer will also change the spread pattern and flow rate. Do not use powdered materials as it will damage the gearbox.
- Gears are permanently lubricated at the factory. Do not open the GEARBOX or dirt may enter.


ASSEMBLY INSTRUCTIONS

STEP 1: Remove and identify all loose parts from carton

STEP 2: Position hopper as shown in Image 1. Install frame using (4) #10 x 1 ¼" Flat Head Phillips screws.

TIGHTEN THESE NOW

STEP 3: Install Gearbox by inserting the Pinion Shaft into hole in center of Hopper's bottom (see Image 2). The **ARROW** on the Gearbox must point to **FRONT** of the Hopper. Follow label instructions on hopper.




STEP 4: Install Lower Handles (left and right) onto Frame and secure with (2) ¼-20 X 2 ¼ inch bolts through hole in Frame Braces and through the hole in the Frame. Secure with (2) ¼"-20 nylon lock nuts on the ends. **DO NOT TIGHTEN DOWN ALL THE WAY.**

STEP 5: Slide the Axle (coast wheel side first) through the right side Lower Handle and into the Gear Box (with the arrow facing the FRONT). You will need to rotate the Axle to engage with the Gear Box, then slide it through the left side Lower Handle as shown in Image 3.


Remove agitator when using Rock Salt to prevent gearbox damage

STEP 6: Install Bearings over the Axle and press into the notches of the Lower Handles, see Image 4.




STEP 7: Install drive wheel to axle using pin hole nearest to lower handles as shown below. Insert 1 ¾" Cotter pin through wheel and through axle. Bend with pliers to prevent pin from falling out.

STEP 8: Install coast wheel to axle using outside pin hole. As shown, add the flat washer, and insert ¾" Cotter pin through axle (not through wheel). Bend with pliers to prevent pin from falling out.




STEP 9: Select (2) ¼" X 1 ½" bolts and (2) ¼"-20 nylon lock nuts to complete these next steps. Now pick up your Handle Shaft and notice that each end has a set of drilled holes. The end that has the holes closest to the end of the shaft is for the top of the unit. The other side of the shaft will be used to attach the handle to the lower handles.


STEP 10: Place the Handle Shaft between the two Lower Handles and secure using the bolts and nuts selected in Step



STEP 11: Take Guage and Linkage Assembly and line up the holes with the Handle Shaft and Upper Handles. Insert (2) $\frac{7}{2}$ bolts through the Guage and Linkage Assembly, Upper Handles, and Handle Shaft. Secure with (2) $\frac{1}{4}$ nylon lock nuts. NOTE: Make sure the Guage and Linkage Assembly is placed on the left side of the Handle. The numbers, wing nut, and lever will be facing out.




STEP 12: Attach Linkage Pivot with a ¼"-20 X 1 ½" bolt, MD flat washer, black spacer, and lock nut (shown below).



STEP 13: Take the bent end of the Control Rod and place it into the keyed shut off plate under the hopper making sure to take out the bow tie clip. The Control Rod will be placed into the first notch closest to the end of the plate. Once the Control Rod has been placed through the notch secure the placement by replacing the bow tie clip.

TIP: Make sure that the Control Rod is above the Lower Handles.



STEP 14: Install the ½" carriage bolt through the Control Rod and install the SM flat washer and hax nut on the carriage bolt as shown above. NOTE: This connection will be loose to allow for the necessary calibration and proper performance of the spreader.

STEP 15: **CALIBRATION**: THIS STEP ENSURES THAT YOUR SPREADER IS PROPERLY ADJUSTED TO GIVE YOU A CORRECT STARTING POINT TO APPLY MATERIALS AT THE CORRECT SETTING. Pull the Control Lever back to #30 on the Gauge and Lever Assembly, then push the shut-off plate forward until the shut-off and the drop holes are fully open. Now tighten the Hex Nut on the ½" Carriage Bolt on the Linkage Assembly (parts from Step 14). Check to confirm calibration by closing the Control Lever to #0, then reopening to #30. If all drop holes are fully closed at #0 and open at #30 then your unit has been calibrated correctly.

STEP 16: Take your Agitator Pin and insert it into the portion of the Pinion Shaft that is located inside the Hopper.





OPERATING INSTRUCTIONS

- Obtain proper setting for material to be used from the enclosed SETTING MATRIX included with this spreader, or from our web site under the MANUALS SECTION.
- Set stop bolt on rate gauge assembly to the proper rate setting.
- While pushing spreader forward, pull control lever back to stop bolt, to stop spreading, push lever forward to close flow holes before you stop moving.
- When finished, empty any remaining material from hopper, rinse spreader, apply coating of light oil to all metal parts. The gearbox is sealed and is factory lubricated.

The **SideSpread-Control** is a patented innovation that is superior to side deflectors. Side deflectors block material leaving the impeller. This blocked material is now consolidated into a 2-3" wide path on the left inside wheel of your spreader. This equates to wasted fertilizer, dark green stripes, and in some cases this extra fertilizer (seven times) will damage the lawn.

SideSpread-Control maintains the correct application rate while not placing material on driveways, sidewalks, flowerbeds, or worse, the storm drains in your street. This saves you money and keeps you from damaging your lawn.


To engage SideSpread-Control:

- 1) Locate the lever on under the right side of the hopper.
- 2) Slide the control lever from the front to the back.
- 3) Position the left wheel of your spreader 6"-12" from the sidewalk, flowerbed, or driveway and spread as normal.
- 4) When you have completed this spreading pass, close the control lever to "0", and then open the **SideSpread-Control™** by sliding the control lever from back to the front, for a **FULL**, 180 degree spread pattern.
